2024 Officers Swearing-In

RCRC Outgoing Chair Remarks

Immediate Past Chair, Supervisor Doug Teeter, Butte County, expressed gratitude to the RCRC Board of Directors for entrusting him as Chair in 2023.

Chair, Supervisor Chris Lopez, Monterey County, presented Supervisor Teeter with a gift as a token of appreciation on behalf of RCRC.

RCRC Incoming Chair Remarks

Chair, Supervisor Chris Lopez, Monterey County, welcomed supervisors to the January RCRC Board of Directors meeting, expressing both eagerness and commitment to serve as RCRC's 2024 Chair. Supervisor Lopez expressed a desire to collaborate closely with Board Members throughout the year.

President's Report

Patrick Blacklock, President and CEO, provided a report on recent activities the organization is engaged in that align with the RCRC Strategic Plan goals, encompassing Equitable Access, Impactful Advocacy, Healthy Communities, and Operational Excellence.

Mary-Ann Warmerdam, Senior Vice President Governmental Affairs, introduced individual members that make up the Government Affairs Department.

Member County Concerns and Issues

Chair, Supervisor Chris Lopez, Monterey County, provided an opportunity for the RCRC Board of Directors to discuss their individual member county concerns and issues. RCRC staff will review the concerns and issues raised by RCRC Board Members and assess each item for possible plans of action.

The RCRC Board of Directors heard from the following supervisors:

- Supervisor Geri Byrne, Modoc County, expressed concerns about the grasshopper infestation Modoc County experienced last year and the lack of response from the USDA Animal and Plant Health Inspection Service. Supervisor Byrne also inquired if other Member Counties lost their 2022 Resource Advisory Committee rollover dollars, requesting that they contact her if so.
- Supervisor Glenn McGourty, Mendocino County, expressed concern about the rising cost share for the construction of the county jail. Supervisor McGourty also discussed the challenges of unfunded mandates and highlighted the costs associated with operating the Ukiah Valley Basin Sustainable Groundwater Agency. Additionally, efforts by the North Coast Regional Water Quality Control Board in Region 1 to implement draft General Waste Discharge Requirements for Commercial Vineyards were mentioned.
- Supervisor Jill Cox, Trinity County, discussed unfunded mandates and the financial strain they cause on small county budgets. Supervisor Cox will be sharing a comprehensive list of unfunded mandates that pose a financial hardship to Trinity County with Senator Mike McGuire.
- Supervisor Ned Coe, Modoc County, inquired about flaws in the 2020 census data and the process for requesting a recount. Supervisor Coe also discussed his concerns about the requirements of the USFS Old Growth Rule and mentioned the due date for comments.
- Supervisor Aaron Albaugh, Lassen County expressed ongoing concerns about the California Department of Fish and Wildlife's regulations on handling wildlife.
- Supervisor Mat Conant, Sutter County, spoke about the concerns of county jail unfunded mandates and the impacts it has on Sutter County.
- Supervisor Rhonda Duggan, Mono County, discussed a severely damaged postal office in Mono County with no response from the United States Postal Office. Despite continuous outreach and news coverage, efforts to address the issue continue.
- Supervisor Kathleen Haff, Tuolumne County, inquired about how other counties are responding to Frontier Communications' bankruptcy and the issue of unreliable service affecting not only Tuolumne County but also other counties facing similar challenges.
- Supervisor Matt Hansen, Tehama County, discussed the impacts of Senate Bill 2 and its concealed weapons requirements. Supervisor Brian Oneto, Amador County, echoed Supervisor Hansen's comments.
- Supervisor Anne Cottrell, Napa County, spoke about wildfire mitigation measures to enhance community safety and advocated for legislative efforts and state initiatives to provide more clarity.
- Supervisor Michael Kobseff, Siskiyou County, discussed reduced funding from the Federal Aviation Administration and expressed a need for support. Supervisor Kobseff also expressed ongoing concerns about public noticing requirements in newspapers, seeking assistance for a shift to electronic methods due to the

absence of a local newspaper. Lastly, Supervisor Kobseff urged fellow Board Members to act as a strong voice for the organization.

State and Federal Legislative Update

Mary-Ann Warmerdam and Sheryl Cohen, Partner, American Continental Group, provided an update on issues being addressed at both the state and federal levels. At the state level, Ms. Warmerdam focused on the start of the 2024 Legislative Session, elections, and leadership changes. At the federal level, Ms. Cohen provided updates on appropriations and RCRC federal priorities. These priorities include the Farm Bill, RCRC's population bill, the bipartisan tax deal, rural hospitals, property insurance, and cannabis.

Sarah Dukett, Policy Advocate, provided an update on RCRC's sponsored bills related to the Brown Act and code enforcement. Ms. Dukett also discussed two additional bills: AB 797 (Weber), focused on police review boards, and AB 702 (Jackson), addressing juvenile justice financing.

Overview of State Budget

Mary-Ann Warmerdam and the Governmental Affairs staff provided a brief overview of the Governor's 2024-25 proposed Budget and its implications for California's rural counties. Ms. Warmerdam encouraged supervisors to peruse *The Rural Rundown*, RCRC's overview on specific issue items of the proposal.

Proposition 1 – The Governor's Behavioral Health Modernization Proposal Sarah Dukett, Policy Advocate, provided an overview of Proposition 1, Governor Newsom's Behavioral Health Modernization Proposal on the March 5, 2024 ballot.

Staff Recommendation

After consultation with the RCRC officers, RCRC staff recommended the RCRC Board of Directors adopt a "No Position" on Proposition 1.

After Board discussion, Supervisor Lori Parlin, El Dorado County, moved that the RCRC Board of Directors take no action with respect to Proposition 1 - The Governor's Behavioral Health Modernization Proposal. Supervisor Daron McDaniel, Merced County, seconded the motion. Motion passed by the following roll call vote taken:

Guest Speaker – California Natural Resources Agency

Wade Crowfoot, Secretary, California Natural Resources Agency (CNRA), addressed the RCRC Board of Directors on the 2024-25 State Budget outlook and potential impacts on key CNRA programs, the 2024 water outlook, an update on the 2024 forest resilience plan, and efforts by the California Department of Fish and Wildlife. The RCRC Board of Directors engaged in discussion with Secretary Crowfoot.
