RCRC Strategic Plan

Carolyn Jhajj, Communications Director, presented on the RCRC Strategic Plan, providing insights into the current 2022-2025 plan, highlighting key accomplishments in 2023, and outlining the proposed development of the 2025-2027 Strategic Plan.
